The decision of the Tribunal was as follows:-

There was a downturn in the respondent's business.

The Tribunal is satisfied that the appellants' employment ended by reason of redundancy and without their notice entitlements. The appellants' are entitled to a redundancy lump sum under the Redundancy Payments Acts, 1967 to 2007 based on the following criteria:

The appellant was placed on temporary on lay off from 26th January to 11th February 2008 and from 13th June to 1st August 2008

Date employment commenced	24 th January 2005
Date employment ended	01 st August 2008
Gross weekly wage	€566.08

The appellant was placed on temporary lay-off from 28th January to 14th February 2008 and from 13th June to 1st August 2008

Fourth named appellant:

Date of Birth	04 th November 1977
Date employment commenced	28 th June 2004
Date employment ended	01 st August 2008
Gross weekly wage	€566.80

The appellant was placed on temporary lay-off from 28th January to 8th February 2008 and from 13th June to 1st August 2008

Fifth named appellant:

Date employment commenced	27 th September 2004
Date employment ended	01 st August 2008
Gross weekly wage	€566.80

The appellant was placed on temporary lay-off from 28th January to 6th February 2008 and from 13th June to 1st August 2008

Date employment commenced	01 st February 2005
Date employment ended	08 th August 2008
Gross weekly wage	€566.80

These awards are made subject to the appellant's having been in insurable employment under the Social Welfare Acts during the relevant period.
