The decision of the Tribunal was as follows: -

Appellants' Case

In sworn evidence, the appellant's confirmed the details of their application to the Tribunal.

Respondent's Case:

The Tribunal was satisfied that the respondent had been properly notified of the hearings. However, there was no appearance by them or representation on their behalf.

Determination:

Accepting the uncontested evidence of the appellants, the Tribunal finds that their appeal under the Redundancy Payments Acts, 1967 to 2007 succeeds and they are awarded a redundancy lump sum, which is to be calculated on the basis of the following criteria:
