## **Preliminary point:**

The Tribunal heard sworn evidence from both the claimant and the respondent.

The claim under the Unfair Dismissals Act 1977 to 2007 was not submitted to the Tribunal within the six-month period as specified in the Act. The claimant could not explain any exceptional circumstances to the Tribunal why this was so. Therefore the Tribunal cannot extend the period for submitting the claim to one year and accordingly the claim is not within the jurisdiction of the Tribunal. The claimant was told this by the Tribunal on the day of the hearing and accepted this position.

## **Determination:**

The respondent agreed the claimant was an employee. The respondent agreed that the claimant 's position was redundant as the respondent company closed down.
