Presuming that the "case management" designation is being recorded in the database, it should be a trivial matter for the official publishing this hearing diary (which appears without the names of parties) to similarly filter the database for the phrase between the dates provided. If it is the case that no record is being kept in the WRC database of which hearings have the "case management" designation, it would be possible to partially fulfil this request (in respect of remote hearings) by providing me with the results of a search of the WRC Post Registration Unit's email account for hearing notifications containing the exact phrase "case management" between the provided dates. As any parties to these cases have by now been afforded the meaningful opportunity to object to a hearing in public referred to in the WRC's hearing guidelines (given that they have by now attended a case management hearing), I believe it would be no longer necessary or appropriate to redact identities save for the subset who have been afforded anonymity by direction of the adjudicator.
